Primary purpose of role

Carry out successful installation and fault finding on Electrical and Instrumentation systems on the GIBP site.

Major duties

Responsible for implementation and reporting on preventative maintenance work, defect rectification, problem solving and project work relating to instrument, electrical and control plant and maintenance equipment at the Immingham Biodiesel Plant.

Support & contribute to the planning & management of day-to-day & longer-term engineering & maintenance activities, balancing commercial and safety considerations and including:

- » Maintaining and repairing process control loops for pump, temperature & chemical dosing control.
- » Carrying out repair & maintenance of electrical motor drive systems and associated control systems including inverter drives and basic motor starting.
- » Fault diagnostics, repairing and modification of programmable logic controllers and ladder logic.
- » Maintaining, repairing and calibrating all types of instrumentation including pressure / temperature transducers, probes and multiple types of flow and depth technology.

Report to the Engineering Team on work progress, explaining reasons for incomplete or delayed work, providing accurate forecasting and planning.

Produce and maintain appropriate site engineering, maintenance and associated documentation and schedules, procedures & records in line with statutory & business needs.

Assist in the development and maintenance of the Computerised Maintenance Management System (CMMS).

Obtain spare parts from local, national and international suppliers in line with site quality procedures.

Contribute to outage, project & improvement activities.

Establish strong, effective relationships with all members of the Immingham Biodiesel plant, it's key customers – internal and external & competent authorities and stakeholders.

Complete all required safety, technical & business training to ensure competence, remaining up to date with general and E,C&I maintenance & engineering best practice, industry trends & statutory requirements.

Be a central contact & information point for other personnel on designated matters.

Contribute to achieving Immingham Biodiesel Plant & Greenergy group business objectives, policies & procedures.

Be part of the site wide out of hours engineering call out rota.
